

## **Outdoor Alcoholic Beverage Dispensing Establishment Registration**

---

### **INTRODUCTION:**

Per Ordinance No. 2021-55, all establishments licensed by the State of Florida to serve alcoholic beverages at a business lawfully operating and located within the City's Entertainment District may dispense alcoholic beverages for outdoor consumption after registration with the City, subject to Ordinance No.: 2021-55, the laws of the State of Florida and the following:

### **OUTDOOR ALCOHOL DISPENSING CRITERIA:**

- The establishment must have a State of Florida Department of Business and Professional Regulations Alcoholic Beverage License to be able to dispense alcoholic beverages by the drink.
- The establishment may dispense alcoholic beverages for outdoor consumption only as permitted under the establishment's State Alcoholic Beverage License.
- The establishment shall register with the City's Zoning Division of the Community Development Department as an Outdoor Alcohol Dispensing Establishment.
- The establishment must have a current Business Tax Receipt and Certificate of Use with the City.
- The establishment shall not dispense to any person more than one alcoholic beverage at a time for removal from the premises, and shall prohibit any person from removing at one time more than one alcoholic beverage.
- The establishment shall only dispense alcoholic beverages for outdoor consumption in a clear plastic cup up to 16 fluid ounce with a City approved logo, as defined in Ordinance No. 2021-55.
- The establishment shall report any violations of the City Ordinance No. 2021-55 to the Police Department.
- The establishment shall keep the area in front of their establishment clean and free of debris.
- The establishment understands, acknowledges and agrees that any violation of State, County or City laws, codes or ordinances or any of the above criteria may result in revocation of outdoor alcohol dispensing privileges and result in denial of any future re-registration or approval.
