Hsu Associates. Member Loeding asked about restrooms capacity space for the public and asked about the issues with the parking space costs. Member Trace suggested to have an entire retail building and a separate parking lot across the streets. Chair Blackwell questioned spacing availability and the timeline of the building construction process.

C. VFW Exterior Improvements Project

Mr. John Davis, City Architect and C.T. Hsu Associates provided a summary of the project scope. The project includes exterior façade and roof replacement.

Mr. William Sturgeon, City Manager, suggested a review the entire project to include design and how much of CRA funds balance is available. Staff was directed to provide construction services for the completion of the project using \$100K from fund balance.


